Thank you for your interest in joining the Affiliate Membership of STI/SPFA. The following will help you become acquainted with the requirements needed to be a member.

**Membership Requirements: Affiliate Membership** in STI/SPFA shall be open to those applicants, wherever located, who establish to the satisfaction of the Board of Directors that they are engaged in the business of supplying components, materials, or services for fabrication of steel products. Any Company (either by itself, or by or through a division or wholly owned or controlled subsidiary) eligible for both Fabricator and Affiliate Membership shall be required to become a Fabricator Member of STI/SPFA. Membership shall be held in the name of the parent, unless fabrication is conducted by or through a division or subsidiary having a name different than the parent; in which event membership shall be held in the name of such division or subsidiary.
